— Essentials

The Pricing Model of Penta consists of two basic elements, the first one is the Basic plan, including the substantially defined services, as well as extra services.

The Basic plans differ in price and services included. The customer chooses one of the available plans and pays a specific monthly fee. In every Basic plan, there are several services included. Anything exceeding the plan will be charged on the usage basis. The final price is thereafter a combination of a fixed basic rate and of a variable amount charged for the ancillary services.

Services, or extra services, are rendered partly by Penta directly, but in most cases by partners (specifically, solarisBank AG). The costs of the services are consequently shown to the customer. These severe fees issued by the partners will be, as far as possible, collected, invoiced or refunded by Penta, as to mind any additional time-consuming expenses for the customer.

— Monthly Basic plans for businesses

For the existing businesses, while in the enrolment process of the business account, there are 3 different monthly plans available, for the customer to choose from:

Basic Plan

The Basic plan is available free of charge. It includes one online-banking user, one Mastercard as well as 50 outgoing SEPA transactions. It is not possible to arrange transactions in foreign currencies or any transactions out of the SEPA payment environment. There are no accounting integrations, nor Penta's Open API-interface available.

If you find yourself in need of more functions, or you would like to expand your business, there is, at any time, the possibility to upgrade to a superior plan.

Advanced Plan

The monthly costs for the Advanced plan are 9 EUR and include 2 online-banking users, 2 Mastercards, as well as 100 outgoing SEPA transactions. It offers you the access to the accounting integrations, as well as the connection to one of the international payment services (Currencycloud), allowing you to arrange the transactions in foreign currencies and outside of SEPA-zone. There is a charge of 1 % of the total amount of currency exchanged by Currencycloud. Additionally, there is a transaction fee (local/SWIFT), which may be withdrawn from our ancillary services. The use of Penta's Open API-interface is not available.

Premium Plan

The cost of the Premium plan for the customer who is incorporating the company is 9 EUR for the first 6 months, instead of the usual 19 EUR. After the six months have passed, the fee of 19 EUR / month will be charged. The Premium plan includes 5 online-banking users, 5 Mastercards, as well as 300 outgoing SEPA transactions. It offers you the access to the accounting integrations, as well as the connection to one of the international payment services (Currencycloud), allowing you to arrange the transactions in foreign currencies and outside of SEPA-zone. There is a charge of 0,5 % of the total amount of currency exchanged by Currencycloud. Additionally, there is a transaction fee (local/SWIFT), which may be withdrawn from our ancillary services. The use of Penta's Open API-interface is possible on the Premium plan.

— Penta credits

The customers may receive Penta credits, which resemble a reward. They will be taken into account at the end of each month. The customers may earn these Penta credits through different actions, e.g. by referring a new customer. It is not possible to cash out these Penta credits or them to be transferred to another customer.

— Terms of change and cancellation

The Penta services are concluded for an indefinite period and will be invoiced monthly. The invoice is issued on the 1st of each month. The monthly fee will be invoiced per day, i.e. if a new contract is closed within a month, only the actual costs will be invoiced on the 1st of the following month.

Upgrades and their accompanying activations of the additional functions and services take immediate effect. The billing is set on per day basis. Only the days when the plan was used will be invoiced.

Downgrades and their accompanying disconnection of additional functions and services take effect on the 1st of the following month. Therefore the new plan is valid starting the following month. It is required that all extra functions and services not included in the new plan are disconnected /canceled timely, otherwise, the downgrade will not be successfully performed.

Upgrades and Downgrades require the customer's acceptance of Penta's Terms & Conditions as well as the acceptance of the price and services of the new plan. A change of a plan is possible to one of the plans available at that time. The customer is not entitled to claim that Penta will continue keeping the current/archived plans in place.
